



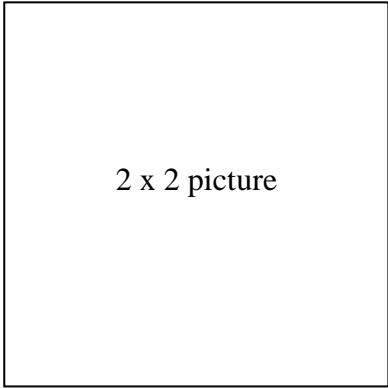

MEMBERSHIP IN ORGANIZATION :

As a candidate for a member of the Board of Directors of Negros Oriental I Electric Cooperative, Inc. (NORECO I), I hereby declare that :

1. I am a Filipino citizen;
2. I am a graduate of a four (4) year course;
3. I am between twenty-one (21) and seventy (70) years old on the date of the election;
4. I am of good moral character;
5. I am a member of the electric cooperative in good standing for the last five (5) years immediately preceding the election or appointment ;

As a member of good standing, therefore;

- a) I have no unsettled or outstanding obligations to the cooperative whether personal or commercial or industrial connections of which I am the owner/co-owner three (3) months prior to the time of filing of the Certificate of candidacy;
 - b) I and my spouse have not been apprehended of electric pilferage by the coop, and;
 - c) I have not been removed for cause as director or employee from any electric cooperative.
 - d) I have not been terminated for cause from public office or private employment ;
 - e) I have not been convicted by final judgment of a crime involving moral turpitude;
6. I am an actual resident and consumer in the district that I seek to represent for at least two(2) years immediately preceding the election;
 7. I have attended at least two (2) Annual General Membership Assemblies (AGMAs) for the last five (5) years immediately preceding the election or appointment.
 8. I am not employed by or financially interested in a competing enterprise or a business selling electric energy or electrical hardware to the cooperative or doing business with the cooperative, including the use or rental of poles.
 9. I and my spouse do not hold any public office;
 10. I am not related to any member of the electric cooperative board of directors, general manager and department managers within the fourth civil degree of consanguinity or affinity.

11. I am not a representative of a juridical person.
12. I and my spouse have not been a candidate in the last preceding local or national elections;
