Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the **NEA Memorandum 2017-019** otherwise known as the "Revised Procurement Guidelines and Public Bidding Procedures for Electric Cooperatives IRR-RA10531 (2017)."
2. Interested parties shall submit their "Letter of Intent" and must comply the accreditation requirements. Deadline of accreditation will be on **March 5, 2025**. There is a non-refundable accreditation fee of **FIVE THOUSAND PESOS** that is valid for one (1) year.
3. For this particular bidding, delinquent contractors listed per Memo 2023-51 dated October 4, 2023 are prohibited to join.
4. The complete set of Eligibility Requirements and Bidding Documents maybe purchased by interested bidders upon payment of a non-refundable fee **as stated above** from the Bids and Awards Committee Secretariat.
5. Only those bidders who have purchased the Bidding Documents are qualified to participate during the pre-bid conference where their presence is **MANDATORY**.
