Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the NEA Memorandum 2017-019 otherwise known as the "Revised Procurement Guidelines and Public Bidding Procedures for Electric Cooperatives IRR-RA10531 (2017)."

Interested parties shall submit their "Letter of Intent" and must comply the accreditation requirements. Deadline of accreditation will be on March 4, 2025. There is a non-refundable accreditation fee of FIVE THOUSAND PESOS that is valid for one (1) year.

For this particular bidding, delinquent contractors listed per Memo 2023-51 dated October 4, 2023 are prohibited to join.
