APPLICATION FOR MEMBERSHIP, RIGHT OF WAY AND ELECTRIC SERVICE

The undersigned, bonafide member of the Negros Oriental Electric Cooperative, Inc. (hereinafter called the COOPERATIVE) hereby applies for the membership with the _____ Barangay Power Association and hereby agrees to purchase electric energy from the “COOPERATIVE” through the Association subject to following terms and conditions, to wit:

1. That the undersigned shall comply with and be bound by-laws policies, rules and regulations promulgated by the Association and Cooperative.
2. That the undersigned shall bind himself with the provisions of the _____ Barangay Power Association Memorandum of Agreement with the Cooperative and any additional provisions that maybe agreed upon by both Parties;
3. That the undersigned shall cause his premises to be wired in accordance with wiring specifications approved by the officers of the Association to enter his premises without being liable to trespass the dwelling for the purpose of collecting payment of electric bills, disconnection of electric service if no payment is entered and in case of the undersigned’s violation of policy on illegal use of electricity, reading, inspecting, or otherwise disposing of its apparatus and property whenever necessary and appropriate.
4. That the undersigned shall protect the electric facilities of the Cooperative within the service area of the Association from being vandalized, stolen or destroyed so as not to jeopardize continuity of electric service to consumers.
5. That the undersigned shall support and cooperate with the officers of the Association in their task to curtail pilferage of electricity and tampering of electric meter, right-of-way easement, clearing of distribution lines and other obstructions that may hamper delivery of electricity or pose danger to life and property;
6. That the undersigned shall pay his electric bills to the Association within seven (7) days upon presentation of said bill. In the event of stoppage of, or failure of, his KWH meter to register the full amount of current consumed, he likewise agrees that he shall be billed for such period on an estimated consumption based upon the use of power in a similar period of like use;
7. That the undersigned shall not, in any manner whatsoever, pilfer electricity either directly or indirectly install illegal and/or unauthorized connections, or tamper his electric meter. It shall be the concern of the undersigned to discourage his co-members from engaging in such illegal activities, or to report to the officers of the Association such consumer who insist on doing them, so as to protect the interest of the Association;
8. That the acceptance of this application shall constitute an agreement between the undersigned and the Association and the recognition of the supervision of the Cooperative over the Association.
