### APPLICATION/CONTRACT FOR ELECTRIC SERVICE

#### DESCRIPTION OR NATURE OF APPLICATION:

#### LOCATION:

The undersigned (hereinafter called the "**Applicant**") hereby makes application to the **NEGROS ORIENTAL ELECTRIC COOPERATIVE, INC. (NORECO)** (hereinafter called "**Cooperative**") for all electric energy required or to be used the premises above referred to. Upon acceptance of the Application by the COOPERATIVE, the APPLICANT agrees as follows:

01. Electric energy shall be taken and used by the **APPLICANT** in accordance with the provisions of the Articles of the corporation and By-Laws of the **COOPERATIVE** and will comply and be bound by the rules and regulations as may from time to time be adopted by the **COOPERATIVE**.
02. The **APPLICANT** will pay monthly to the **COOPERATIVE**, as its office, all electric energy furnished to their end in accordance with **COOPERATIVE** rates as may be determined and adopted by the **COOPERATIVE** from time to time in accordance with the rules and regulations of the Energy Regulatory Board. Provided however, that the **COOPERATIVE** may limit the amount of electric energy to be furnished for industrial purposes when circumstances requires.
03. The **COOPERATIVE** expressly authorizes and empowered to remove its property and discontinue furnishing electric energy should **APPLICANT** fail to comply with any of the rules and regulations of the **COOPERATIVE** or become delinquent with their account of the **COOPERATIVE** for electric energy used. Further, it is understood that notice of disconnection is not necessary since the electric bill contains the statement of account and date when the bill becomes due.
04. The **APPLICANT** agrees to maintain in proper and safe condition of the wiring installations within their premises throughout the life of this Agreement in accordance with the Philippine Electrical Code or existing laws, rules and regulations governing electrical connections. The **APPLICANT** shall also notify the **COOPERATIVE** for any change in load, whether an increase or decrease.
05. The **APPLICANT** agrees to allow only employees of the **COOPERATIVE** with proper identification cards, to make any internal adjustment of KWH meters or other equipment of the **COOPERATIVE** installed in the **APPLICANT's** premises and that he shall be held responsible for tampering, interfering with or breaking the seal of said KWH meters or equipment installed within their premises. Further, the **APPLICANT** shall allow the **COOPERATIVE** the right of ingress and egress in their premises the course of the latter's operation and maintenance of its electrical system.
06. The **APPLICANT** agrees to absolutely refrain from extending a connection to another person's house, apartment, dwelling, or extension of lines across streets, and the like, without first securing a written consent from the **COOPERATIVE**.
