The undersigned hereby applies for membership in the **NEGROS OREINTAL ELECTRIC COOPERATIVE, INC. (NORECO I)** hereinafter called the ("COOPERATIVE") and in consideration of the acceptance of this application agree with the Cooperative as follows:

1. The undersigned will pay on demand to the Cooperative Fee of **FIFTY PESOS (Php50.00)**;
2. The applicant will, when the electric energy becomes available, purchase from the Cooperative all electric energy used in the premises described and will pay therefore at rates and
3. approved by the Energy Regulatory Commission (ERC), provided, however, that the Cooperative may limit the amount of the electric energy to be furnished for industrial uses.
4. The undersigned will grant to the Cooperative **FREE OF CHARGE**, at its request the necessary rights and easements to construct, operate, replace and perpetually maintain, on the property owned or leased by the undersigned and in or upon all roads, streets or, and highways abutting said property its line or lines for the transmission or distribution of electric energy and will execute and deliver to the Cooperative any conveyance, grant or instrument which the Cooperative shall deem necessary or convenient for said purpose or any of them. All service line supplying the undersigned with electric energy and all switches, meters and appliance and equipment constructed and installed by the Cooperative on said property, except so much thereof, if any, shall be paid for by the undersigned, shall at all times be the sole property of the Cooperative and the Cooperative shall have the rights of access to said property to repair, service and upon the discontinuance of service for any reason to remove the same. The right-of-way herein, however shall subsist during continuing operation of the Cooperative and its successors and assigns;
5. The undersigned shall have all the rights and privileges granted to members under the charter and by-laws of the Cooperative and or the Magna Carta and by-laws and rules and regulations may from time to time be adopted by the Board of Directors of the Cooperative;
6. An applicant shall only become a member after he shall have paid the membership fee and his application approved by the Board of Directors. Attendance to an orientation seminar is necessary prior to electric connection;
7. A member assumes no personal liability or responsibility for any debts or liabilities of the Cooperative and it is expressly understood that under the law his private property cannot be attached for any such debts or liabilities.

The acceptance of this application by the Cooperative shall constitute an agreement between the Cooperative and the undersigned upon the terms herewith set forth and the contract for electric service shall be enforce from date service is made available by the Cooperative to the applicant, the same remain in force by either party by giving at least fifteen (15) days written notice.

It is understood that re-installation for service disconnection by reason of non-payment of electric bill shall be made upon payment on the prescribed Reconnection Fee.

The undersigned (hereinafter called the "Applicant") hereby makes application to the NEGROS ORIENTAL ELECTRIC COOPERATIVE, INC. (NORECO I) (hereinafter called the "Cooperative") for all electric energy acquired or to be used on the premises above referred to. Upon acceptance of the application by the COOPERATIVE, APPLICANT agrees as follows:

1. Electric Energy shall be taken and used in accordance with, and APPLICANT, will comply with and be bound by the provisions of the Certificate of Incorporation and By-laws of the COOPERATIVE, and the rules and regulations as may from time to time be adopted by the COOPERATIVE.
2. The APPLICANT will pay monthly to the COOPERATIVE at its office for all electric energy furnished hereunder in accordance with the COOPERATIVE rates as determined from time to time in accordance with the By-laws of the COOPERATIVE and rules and regulations as may from time to time adopted by the COOPERATIVE. Provided however, that the COOPERATIVE may limit the amount of electric energy to be furnished for industrial purposes.
3. The APPLICANT shall perform his rights and responsibilities as a member of the COOPERATIVE.
4. The COOPERATIVE is expressly authorized and empowered to remove its property and discontinue furnishing electric energy should APPLICANT fail to comply with any of the rules and regulations of the COOPERATIVE or become rights of egress upon and over, the ingress from said premises. Further, it is understood that notice of disconnection is not necessary since the electric bill contains the statement of accounts and date when the bill becomes due.
5. The APPLICANT agrees to maintain the wiring installation within the premises in the proper and safe condition throughout the life of this agreement and notify the COOPERATIVE of any change in load. The sole obligation and responsibility to maintain the wiring installation after the electric meter shall belong to the applicant consumer and the COOPERATIVE shall be liable for any negligence or damages for negligent wiring after the electric meter.
6. The APPLICANT agrees to allow no one, except employees of the COOPERATIVE with proper identification cards to make any internal adjustment of any meter or other equipment of the COOPERATIVE, installed in the APPLICANT'S premises and to hold responsible for tampering, interfering with or breaking of seal of said meter or equipment.
7. The APPLICANT agrees to absolutely refrain from giving or allowing connection from his premises to another house, apartment, dwelling, etc. or extending a connection across the street without first securing a written consent from the COOPERATIVE.
